PROMOTIONAL PERIOD

- The Promotion will run in JG Speedfit stockists/retailers from 3rd April 2018 until 29th September 2018.

ELIGIBILITY & ENTRY

- The Promotion is only open to residents of the United Kingdom (including England, Scotland, Wales and Northern Ireland), Channel Islands and the Isle of Man aged 18 or over, excluding all employees and the families of employees of the Promoter, affiliated companies, and those of its participating distributors, agents and anyone else professionally connected with the Promotion.
- To enter, participants must:
 - Purchase a promotional pack of JG Speedfit 15mm Equal Elbows (Product Code: PEM0315W) from a JG Speedfit stockist/retailer during the Promotion period, whilst stocks last and subject to availability. Promotional packs will be clearly labelled and will contain a unique entry code inside the packaging.
 - Participants must register the unique entry code by visiting www.speedfit-giveaway.co.uk and completing and submitting the online entry form, including contact details, the unique code and name and location of the stockist where the item was purchased.
